The SLMTs must necessarily include the State MIS Nodal Officer. **Note: TA/DA of the participants is to be borne by the State Govts.; however, boarding and lodging of the participants during the training will be borne by the Organizer.**

3. The MIS Nodal Officers may bring an updated status of printing of the revised AWC Registers and Reports in their respective States/UTs. It is requested that the participants must arrive at the venue of training positively by the evening of 2 June and may leave only in the late evening of 5 June or on the next day, as the training sessions will continue from 9.00 AM to 6.00 PM every day.
