The expenditure is dubitable to the Major Head "3602 Grants-in-aid to State Government; 04-Grants for Centrally Sponsored Plan Schemes (Sub Major Head); 358-Social Welfare-Child Welfare (Minor Head); 02 Integrated Child Development Services; 05.01 General Component;5.01.31 Grant-in-aid (Plan) under Demand No.105 of the Ministry of Women and Child Development for the year 2013-14.
- 5. The amount of grant-in-aid is finally adjustable in the books of the Principal Accounts Officers, Ministry of Women & Child Development, New Delhi. Payments to State Government would be arranged through the Reserve Bank of India, Nagpur.
