Dear

Please refer to my D.O. letters of even number dated 11th January, 2016, 4th February, 2016 and 16th March, 2016, regarding revamping of Web-based MIS on ICDS Scheme (**Copy enclosed**).


2. As you are aware, States/UTs were requested to sensitize about the features of the Rapid Reporting System (RRS), i.e., Input Proforma, Output Proforma and Dashboard during the State Secretary's Conference held on 22nd February, 2016, at Vigyan Bhavan, New Delhi and above mentioned letters also. States/ UTs were also requested to complete assigning and uploading of the 11 digit unique code to RRS of ICDS, etc. so that data of AW-MPR for the month of March 2016 and onwards can be entered online onto RRS of ICDS w.e.f. 01.04.2016.

3. While reviewing the status as on 11.04.2016, it has been observed that 11.18 lakhs AWCs, out of 13.49 lakhs operational AWCs, have been assigned 11 digit unique code so far and the remaining 2.31 lakhs are pending for uploading 11 digit code onto RRS of ICDS. Similarly, 1.07 lakhs AW-MPR, out of 13.49 lakhs operational AWCs, have been feed by the Supervisors onto RRS of ICDS at link <http://icds-wcd.nic.in/icds>. It was decided by this Ministry that all the AW-MPR must be entered online onto RRS of ICDS by 10th April 2016. However, keeping in view the difficulties faced by the States/ UTs, the data entry of the AW-MPR for the month of March 2016 would be open till 22.04.2016.

4. I would, therefore, once again request you kindly to review the status of implementation of RRS of ICDS Scheme in the State and ensure that the same is implemented with effect from 01.04.2016 and that 11 digit unique code is assigned to all the remaining AWCs and data for the month ending March, 2016 fully entered for each and every AWCs in your State/UT latest by 22.04.2016.

Please refer to my D.O. letters of even number dated the 11th January, 2016 and 4th February, 2016 regarding revamping of Web-based MIS on ICDS Scheme.

2. As you are aware, revised Input Proforma designed for the Revised Web-based MIS (Rapid Reporting System) was circulated to the States vide my letter dated 04.02.2016. The States/UTs were also sensitized about the features of the Rapid Reporting System (RRS), i.e. Input Proforma, output Proforma and Dashboard during the State Secretary's Conference held on 22nd February, 2016, at Vigyan Bhavan, New Delhi. States/ UTs were expected to complete all the preparatory work like distribution of Input Proforma (Anganwadi Monthly Progress Report) to all AWCs, assigning and uploading of the 11 digit unique code to RRS of ICDS, etc. by 29.02.2016. In order to implement the RRS of ICDS w.e.f. 01.04.2016, States/ UTs were requested to instruct the CDPOs & Supervisors to upload the revised Anganwadi MPR data for the month ending 31.03.2016 onto the RRS using the existing Username and password.

3. In this context, I wish to inform you that Software of RRS relating to data entry module as prepared by NIC is ready and is available at link <http://icds-wcd.nic.in/icds>. I hope that the concerned functionaries of ICDS in the States/UTs, viz., CDPOs, Supervisors and AWWs are well informed and sensitized on the matter so that transition to the Revised Web based MIS w.e.f. 01.04.2016 is smooth. A **copy** of the Operational Guidelines for RRS on ICDS is **enclosed** for ready use by the ICDS functionaries.
