
I am directed to convey the sanction of the President to the release of grants-in-aid amounting to Rs.50,96,19,750/- (Rupees Fifty Crore Ninety-Six Lakh Nineteen Thousand Seven Hundred Fifty Only) as the 1st installment during 2015-16 to the States mentioned below for un-interrupted implementation of Regular Training (job/refresher/induction) for the ICDS functionaries:

2. The payment is provisional and is subject to final adjustment in the light of audited figures of actual expenditure for the year as a whole *vide* Ministry of Financial Letter No. 2 (19).II/20 dated .10.64, as amended from time to time, addressed to all State Governments, etc.
3. The expenditure is debitable to the Major Head '3601' Grants-in-aid to State Government; 02-Grants for Centrally Sponsored Plan Schemes (Sub Major Head); 358-Social Welfare-Child Welfare (Minor Head); 05-Integrated Child Development Services; 05.01-General Component; 05.01.31-Grants-in-aid General (Plan) under Demand No. 108 of the Ministry of Women and Child Development for the year 2015-16.
4. The amount of grants-in-aid is finally adjustable in the books of the Principal Accounts Officers, Ministry of Women & Child Development, New Delhi. Payment to the State Government would be arranged through the Reserve Bank of India, Nagpur. The Accountant General will send intimation regarding receipt of the grant-in-aid to the Principal Accounts Officer, Ministry of Women and Child Development, D-Wing, Shastri Bhawan, Ground Floor, New Delhi.
5. The grant-in-aid is as per the extant financial norms contained in this Ministry's letter No. 8-1/2013-TR dated 7th November 2013 and is subject to the following conditions:
 - a) usual terms and conditions of GFR/Scheme will be applicable;
 - b) the present installment of grant being released is on ad-hoc basis subject to adjustment depending upon the cost sharing ratio between the Centre and State/UTs under the ICDS Scheme as may be decided by the Central Government and;
 - c) States/UTs shall be required to contribute adequate amount for implementation of the ICDS Training programme.
6. The State Governments may ensure the following:
 - a) Out of the above grant-in-aid, no expenditure would be incurred on any other training till the STRAPs for 2015-16 are approved by the Govt. of India;
 - b) Submit the STRAP for 2015-16, if not already submitted;
 - c) Submit the utilization certificates along with SOE for 2014-15, if not already submitted;
 - d) Submit the physical and financial progress report in the prescribed format on quarterly basis;
 - e) Make optimal use of the capacity of the existing Training Centres (AWTCs/MLTCs)
7. Further release of grants-in-aid will be subject to approval of STRAPs/APIPs for 2015-16 by the Competent Authority and timely submission of the information as mentioned above.
8. This sanction issues with the concurrence of IFD/MoWCD *vide* their Dy. No.864/JS & FA/2015-16, dated 24th July 2015.
