Supplementary STRAP for 2012-13 - Approval of - Regarding**


Madam,

I am directed to refer to your letter no. 403/2012-13/W&CDD, dated 11 March 2013 on the above mentioned subject and to convey approval of the competent authority to the proposal on Induction Training of ICDS Functionaries on Revised MIS for an amount of **Rs. 13.70 lakh** as supplementary to the already approved State Training Action Plan (STRAP) for 2012-13 and as per the statement enclosed herewith.

2. It may be noted that the consolidated funds released under the ICDS Training programme may be utilized for conducting induction training on revised MIS. Expenditure incurred for this training may be reported separately in the QPR for ICDS Training programme. Since the training on revised MIS will spillover to the next FY, this approval of the supplementary STRAP for an amount of **Rs. 13.70 lakh** would remain valid in the next year too, till completion of all three levels of training.

3. You are requested to take all necessary actions to undertake the induction training on revised MIS (level 2 & 1) as well as organization of the 1-day orientation workshop *strictly* following the GoI guidelines dated 28<sup>th</sup> August 2012 and also orientation of the State level Master Trainers (SLMTs) from Sikkim by the Central Team during the Regional Training of Trainers held on 11-13 December 2013 at Kolkata, so as to ensure full roll-out of revised MIS across the State in a time bound manner. A detailed timeline for undertaking induction training at three different levels clearly aligning with the delivery of printed AWC Registers may be shared with us urgently.
