Subject: Release of 1st Installment of Grants-in-Aid to Delhi for implementation of ICDS Training Programme during 2014-15 - Sanction - Reg.

Sir,

I am directed to convey the sanction of the President to the release of grant-in-aid amounting to Rs. 72, 72,000/- (**Rupees Seventy two lakh and seventy two thousand only**) as 1st installment during 2014-15 to Govt. of NCT Delhi for un-interrupted conduct of Regular Training (job/refresher/induction.

2. The payment is provisional and is subject to final adjustment in the light of audited figures of actual expenditure for the year as a whole *vide* Ministry of Financial letter No. 2 (19).II/20 dated 9.10.64, as amended from time to time, addressed to all State Governments, etc.
3. The expenditure is debitable to the Major Head "3602' Grants-in-aid to State Government; 02-Grants for Centrally Sponsored Plan Schemes (Sub Major Head); 358-Social Welfare-Child Welfare (Minor Head); 02 Integrated Child Development Services; 02.01 General Component; 2.01.31 Grant-in-aid (Plan) under Demand No.105 of the Ministry of Women and Child Development for the year 2014-15.
4. The Grant-in-aid is finally adjustable in the book of the Pay & Accounts Office, Ministry of Women & Child Development, New Delhi. The Drawing & Disbursing Officer of the Ministry of Women & Child Development will draw & disburse the amount of Rs.72, 72,000/- to the Govt. of NCT of Delhi through a Cheque in favour of the Secretary, Finance Department, Govt. of NCT of Delhi.
5. The grant-in-aid is as per the extant financial norms contained in this Ministry's letter No. 11-13/2006-TR-1 dated 21.4.2009.
6. The State Government may ensure the following:
 - (a) *Out of the above grant-in-aid, no expenditure would be incurred on any other training till the STRAPs for 2014-15 are approved by the Govt. of India;*
 - (b) *Submit the utilization certificates along with SOE for 2013-14, if not already submitted;*


(c) *Submit the physical and financial progress report in the prescribed format on quarterly basis; and*

(d) *Make optimal use of the capacity of the existing Training Centres (AWTCs/MLTCs)*

7. Further release of grant-in-aid will be subject to approval of STRAP/ APIP 2014-15 by the Competent Authority and timely submission of the information as mentioned above.
