Subject: Release of 1st installment of Grants-in-Aid to Government of Sikkim for implementation of ICDS Training Programme during 2015-16 - Sanction - *Regarding*.

Sir,

I am directed to convey the sanction of the President to the release of grants-in-aid amounting to Rs.9,69,250/- (Rupees Nine Lakh Sixty-Nine Thousand Two Hundred Fifty only) to the Government of Sikkim as 1st installment for the 1st and 2nd quarters of 2015-16 for un-interrupted implementation of Regular Training (job/refresher/induction) of the ICDS functionaries.


2. The payment is provisional and is subject to final adjustment in the light of audited figures of actual expenditure for the year as a whole *vide* Ministry of Financial letter No. 2 (19).II/20 dated 9.10.64, as amended from time to time, addressed to all State Governments, etc.

3. The expenditure is debitable to the Major Head '3601' Grants-in-aid to State Government; 02-Grants for Centrally Sponsored Plan Schemes (Sub Major Head); 358-Social Welfare-Child Welfare (Minor Head); 05 Integrated Child Development Services; 05.01 General Component; 05.01.31 Grant-in-aid General (Plan) under Demand No.108 of the Ministry of Women and Child Development for the year 2015-16.

4. The amount of grants-in-aid is finally adjustable in the books of the Principal Accounts Officers, Ministry of Women & Child Development, New Delhi. The Drawing & Disbursing Officer, Ministry of Women & Child Development will draw & disburse the amount of Rs. 9,69,250/- through a crossed Demand Draft in favour of Secretary (Finance), Government of Sikkim, Gangtok.

5. The grants-in-aid is as per the extant financial norms contained in this Ministry's letter No. 8-1/2013-TR dated 7th November 2013 and is subject to the following conditions:

- usual terms and conditions of GFR/Scheme will be applicable;*
- the present installment of grant being released is on ad-hoc basis subject to adjustment depending upon the cost sharing ratio between the Centre and States/UTs under the ICDS Scheme as may be decided by the Central Government; and*
- States/UTs shall be required to contribute adequate amount for implementation of the ICDS Training programme.*

6. The State Government may ensure the following:
- Out of the above grants-in-aid, no expenditure would be incurred on any other training till the STRAP for 2015-16 is approved by Govt. of India;
 - Submission of the STRAP for 2015-16, if not already submitted;
 - Submission of the utilization certificates along with SOE for 2015-16, if not already submitted;
 - Submit the physical and financial progress report in the prescribed format on quarterly basis;
 - Make optimal use of the capacity of the existing Training Centres (AWTCs/MLTCs)
7. Further release of grants-in-aid will be subject to approval of STRAP/ APIP 2015-16 by the Competent Authority and timely submission of the information as mentioned above.
8. This sanction issues with the concurrence of IFD/MoWCD vide their DY. No.864/JS & FA/2015-16, dated 24th July 2015.
