

Subject: Minutes of 5th Meeting of Executive Committee of POSHAN Abhiyaan.

5th Meeting of Executive Committee of POSHAN Abhiyaan (Prime Minister's Overarching Scheme for Holistic Nourishment) was held on 22nd January, 2019 at Civil Services Officers' Institute (CSOI), New Delhi under the Chairmanship of Secretary, Ministry of Women and Child Development (MWCD).

**Minutes of 5th Meeting of Executive Committee of POSHAN Abhiyaan held on
22nd January, 2019 at CSOI, New Delhi**

Executive Committee which is an apex body for all nutrition related activities under the POSHAN Abhiyaan, convened its 5th Executive Committee Meeting on 22nd January, 2019 at Civil Service Officers Institute (CSOI), New Delhi under the Chairmanship of **Shri Rakesh Srivastava**, Secretary, Ministry of Women and Child Development (MoWCD).

2. The list of participants is annexed at **Annexure I**.
3. At the outset, Shri Aditya Chopra, Executive Director, POSHAN Abhiyaan, welcomed all members and presented the Agenda for the meeting.
4. **Shri Rakesh Srivastava, Secretary, MoWCD** at the outset wished all participants a prosperous New Year. In his opening remarks, he expressed his satisfaction on the pace of roll-out of POSHAN Abhiyaan in the year 2018 and exhorted everyone to sustain the tempo going in the year 2019 too, to realize the goals and targets set for the Mission. He informed the members that preparatory meeting on Agri Nutrition Conference was held this month and a National Level Agri Nutrition Workshop is planned to be organised in March, 2019. He also apprised the participants that DoNER has joined hands in the journey of POSHAN Abhiyaan with MoWCD to improve nutritional status in the North-Eastern Regions (including Sikkim). He emphasised that DM/DCs in Executive Committee should act as role models and monitor all the components of the Mission and become examples for others. He advised all the States/UTs to complete the procurement of Smartphones and GMDs latest by 7th February 2019.
5. Shri Aditya Chopra, Executive Director, POSHAN Abhiyaan started with confirmation of minutes of 4th Executive Committee Meeting held on 03rd December, 2018. The Executive Committee confirmed the same. Thereafter, the Action Taken (ATR) Reports on 4th Executive Committee Meeting and 3rd National Council Meeting were presented. The same are attached at **Appendix- A & Appendix- B**.
6. Point wise ATR of 4th Executive Committee held on 03rd December, 2018 were discussed as under:
 - (a) Formulation of VHSND Guidelines: Executive Committee was informed that a review committee will be formed by MoH&FW and a meeting is being planned in the month of February, 2019 to finalize the VHSND guidelines.
 - (b) With respect to the National Nutrition Report, Secretary MoWCD pointed out that lately many institutes and organisations are coming out with reports on nutritional aspects in the country. Therefore, National Nutrition Report being formulated by NIN should be presented with utmost caution backed with thorough research and offered with authenticated data. Detailed Project Report (DPR) which was forwarded by NIN to MoWCD was sent to NITI Aayog for review, has been received with some observations. The observations of NITI Aayog were shared with the Committee members and it was directed that NIN should revise and incorporate suggestions of NITI

Aayog in their Detailed Project Report (DPR) and send a revised version to MWCD for approval.

[Action: NIN]

(c) Evaluation of POSHAN Abhiyaan by NIN: NIN informed that various groups and committees have been finalised during the workshop which was held from 02nd to 04th January, 2019 at Hyderabad. The structure of the report will be finalised in consultation with MoWCD and NITI Aayog in February, 2019.

[Action: NIN]

(d) Addressing the issue of expediting of opening of balance 37000 AWC, the Mission Director informed that Bihar has committed to open 18000 out of 23000 approved AWC by end of February, 2019. Odisha too has given assurance to open 5172 AWCs by next month.

[Action: Bihar & Odisha]

(e) On the issue of rice fortification the Committee was informed that matter is under consideration at the Ministry. Representative of DoF&PD further informed that SFC meeting will be held shortly and further action will be taken on priority basis thereafter. The Executive Committee was informed that Secretaries of MoH&FW, MoWCD and DoF&PD in May, 2016 had forwarded draft Regulations to FSSAI with an intent to make Food Fortification 'Mandatory'. Further, MoWCD on 10th July, 2017 had mandated use of Fortified Oil, Fortified Wheat Flour and DFS in Anganwadi Services. Regarding rice fortification, FCI procures paddy which is milled by the millers, hence the ideal place to carry out fortification is at the mills. Price of fortified rice is reportedly about 30 to 40 paisa per Kg which could be taken as part of procurement incidentals and be part of the overall food subsidy. Fortified rice kernels reportedly have a shelf life of about 2 years as compared to 3 years for normal rice. Therefore, fortified rice can be packaged in differently tagged gunny bags and stored in separately earmarked sheds viz. Rice for Anganwadi services & MDM.

[Action: DoF&PD]

(f) On the issue of collaboration between MoWCD & MoAYUSH, it was informed that Joint Working Group meeting will be held under MoAYUSH and innovation pilots will be designed by Joint Working Group and outcomes will be further discussed in the next Executive Committee meeting.

[Action: MoAYUSH]

7. Action Taken Report of 3rd National Council Meeting Decision points, held on 14.11.18 was discussed and decisions taken were as follows:

(a) Ministry of Drinking Water & Sanitation should send a report on infrastructure assessment, facility of toilets & running water in Anganwadi

Centres and Schools, to MoWCD to be presented to VC, NITI Aayog in National Council Meeting on 12th February, 2019.

[Action: MoDWS]

(b) It was brought out in the ATR that twenty-two States are in the process of procuring Smartphones, which is under different stages of procurement. Participating States were directed to expedite procurement of Smartphones and GMDs.

[Action: Chhattisgarh, Rajasthan, Uttar Pradesh]

(c) On the issue of Conditional Cash Transfer (CCT), Chairperson inquired about the test bed locations for the pilot project and directed representatives of Uttar Pradesh and Rajasthan to revisit the selection of blocks to fulfil all conditionally required for the CCT pilot and intimate the CPMU by 15th February, 2019.

[Action: Uttar Pradesh, Rajasthan]

(d) States/UTs were exhorted to utilize the disbursed funds and send the Utilization Certificate at the earliest.

[Action: All States / UTs]

(e) Another important issue referred in National Council was regarding talking points / Booklets on nutrition under POSHAN Abhiyaan to be given for sensitization of MLA/MPs. The Committee had decided that the DMs/DCs and MPs & MLAs should be oriented on POSHAN Abhiyaan. In this regard, it was directed by the Chairperson to prepare booklets for MP/MLAs and be sent to NITI Aayog for vetting of contents by 15th February, 2019.

[Action: CPMU]

8. Shri Aditya Chopra, Executive Director, apprised the Committee regarding innovation guidelines issued by CPMU to all States/UTs in January, 2019 and gave a brief on the forthcoming events viz., Light House, India and Optima Nutrition in the month of February, 2019.

9. Launch of Online Nutrition Modules was carried out before the Executive Committee by NIN.

10. **Points from Members/State Governments:**

(a) **Dr. R.C. Panda, Member, Board for Coalition for Food & Nutrition Security** brought out the following points.

(i) Various activities of different programs /schemes implemented in States/UTs which are overlapping should be properly coordinated and converged suitably to make an impact.

(ii) Actions carried out by Ministry of Drinking Water & Sanitation should be properly mapped and their impacts analyzed.

(iii) Participation of certain known and established NGOs in various programmes/events of POSHAN Abhiyaan should be encouraged.

(b) **Ms. Gayatri Rathore, Secretary WCD, Rajasthan:** Secretary, WCD Rajasthan gave a detailed account of roll-out of all components of POSHAN Abhiyaan in her State and assured the members that all targets, as directed by the Chairperson, will be achieved on due dates. She informed that Baran and Ajmer have been chosen as locations for Cash Transfer Pilot.

(c) **Ms. Kamesh Gupta, JPC, Uttar Pradesh:** Representative from Uttar Pradesh informed that approximately two lakh AWC will be made functional by March, 2019 in the State. She also informed about various other activities being carried out in the State.

(d) **Shri Rakesh Vyas, Project Director, Gujarat:** Representative from Gujarat informed that the procurement of Smartphones in the State is being expedited. The representative was directed to procure Smartphones as per specifications provided in the Administrative Guidelines.

(e) **Shri Sajid Menon, JPC, Chhattisgarh:** The officer from Chhattisgarh pointed out the following:

(i) Repairing of Smartphones bought in the year 2016 is not cost effective. It was clarified that the matter needs careful examination to evolve any replacement policy, if needed.

(ii) It was brought out that Dashboard does not give details of eligible AWW and AWH at the State/District level for grant of incentives to the AWW and AWH. Executive Committee was informed that Software Development Team would be instructed to incorporate the feature to enable State/UTs to cull out the lists for payment of incentives

(iii) Consultant of ISSNIP were recruited in 2014. They joined with pay package of Rs 60000/- and increment of 8% pa. In 2018, they are being paid Rs 78000/- approx. However, in POSHAN Abhiyaan they started with Rs 60000/- which requires a revision as the amount is meager to hire good talent in view of increased work load of the consultants due to increase in number of districts in the State. It was clarified that any policy decision involving financial effects would have to be within the ambit of the Government approval for POSHAN Abhiyaan.

(f) **Shri Hemen Das, Government of Assam.** Representative from Assam informed that the procurement of Smartphones in the State is being

expedited. He also informed that provision of local kitchen gardens in AWCs has been taken with assistance from the World Bank in the State.

11. Decisions taken in meeting are as follows:

(a) All States/UTs to procure Smartphones and GMDs before 15th February, 2019.

[Action: States/UTs]

(b) Request of Gujarat to amend MDM can't be considered as the specifications of Smartphones has been ratified by the National Council in its last meeting held on 14th November, 2018

[Action: Gujarat]

(c) In the next Executive Committee meeting few other States/ UTs should share the best practices before the Committee.

[Action: States/UTs]

(d) Strategies to tackle malnutrition in urban areas should also be addressed under POSHAN Abhiyaan.

[Action: NULM, MoHUA and NRLM]

(f) All the Ministries/Departments as well as the States/UTs should comply with the directions of National Council & Executive Committee and furnish regular feedbacks.

[Action: Line Ministries & States/UTs]

12. Finally, the Chairperson expressed his concern regarding the low turnout of officers from the Line Ministries and also from the States. Chairperson pointed out that the proceedings of Executive Committee are monitored at NITI Aayog and at PMO level, hence officers should not be absent from the meeting. Officers of the level of JS/ JS Equivalent or above should attend the meeting for meaningful discussions and decisions in the meetings of the Executive Committee.

Meeting ended with Vote of Thanks to the Chair.
